No animal is ever euthanized due to space or time considerations.

PROPERTY

Anything donated on behalf of Kitty Korner Café becomes the property of Kitty Korner Café. No compensation should be expected by any volunteer.

INJURY & ILLNESS

Working with animals may be dangerous and could lead to serious injury, illness or even death. As a volunteer you need to understand and agree to personally assume any and all of the liability and risk associated with volunteering for Kitty Korner Café. Furthermore, each volunteer agrees to hold harmless Kitty Korner Café, its directors, officers, agents, employees and other volunteers from any responsibility or liability for any and all illnesses, injuries or death which may occur as direct or proximate result of their involvement with Kitty Korner Café and Cat Rescue.

TETANUS SHOT

A volunteer must be current on his/her tetanus shot. Alternatively, the volunteer acknowledges that failure to acquire and remain current on a tetanus vaccination may put the volunteer at risk and hereby agrees to hold harmless Kitty Korner Café, its directors, officers, agents, employees and volunteers from any responsibility or liability for any and all illness, injuries or death as a result.

- As a volunteer working with cats, I am expected to:
 - Treat the animals with respect and kindness.
 - o Report animal injuries, illnesses or behavior concerns to a staff member.
 - Never handle an animal that makes me feel uncomfortable.
 - O Not put myself, the animal or others at risk.
 - Follow all posted instructions in animal care areas. This includes not entering a restricted area, such as the quarantine room, without permission.
